- (1) On February 23, 2017, 2,128 restricted shares of Mr. Foust's Company stock, granted March 9, 2015, vested. On February 23, 2017, Mr. Foust automatically surrendered 1,073 of the 2,128 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
- (2) On February 23, 2017, 4,173 restricted shares of Mr. Foust's Company stock, earned February 15, 2016, vested. On February 23, 2017, Mr. Foust automatically surrendered 2,103 of the 4,173 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting.
