This director has elected to defer payment under the Restricted Stock Unit Deferral Program (the "Program") of the restricted stock units issued under the Circuit City Stores, Inc. 2000 Non-Employee Director Stock Incentive Plan. Vested deferred shares are held as "phantom stock" in a phantom stock account. Dividends on vested and unvested shares will be reinvested until distributions are made. The shares underlying the phantom stock units in the director's account will be distributed to the director when he or she ceases to serve as a director of the company.

(1) Thirty-three and one third percent (33 1/3%) of the restricted stock units granted on 6/15/2004 have vested and this director has elected to defer receipt of the restricted stock until he ceases to serve as a director of the Company.

(2) Thirty-three and one third percent (33 1/3%) of the Units paid as a dividend in connection with the restricted stock units granted on 6/15/2004 have vested and are now included in the phantom stock account until the reporting person ceases to serve as a director of the company.

(3) Thirty-three and one third percent (33 1/3%) of the restricted stock units granted on 9/1/2003 have vested and this director has elected to defer receipt of the restricted stock until he ceases to serve as a director of the Company.

(4) Thirty-three and one third percent (33 1/3%) of the Units paid as a dividend in connection with the restricted stock units granted on 9/1/2003 have vested and are now included in the phantom stock account until the reporting person ceases to serve as a director of the company.
