The Registrant was unable to file its annual report on Form 10-K for the fiscal year ended December 26, 2015 by the prescribed date without unreasonable effort or expense due to delays involved in the compiling of the Company's financial information to produce final financial statements and related supporting documentation. The delay in filing the annual report on Form 10-K is caused by the delayed filing of the Form 10-Q for the third quarter 2015, filed on February, 16, 2016, which reflected a restatement of self-insurance reserves. The Registrant plans to file the Form 10-K no later than the fifteenth calendar day following the prescribed due date, as permitted by Rule 12b-25.
