- This option was previously reported as an option for 72,327 shares of common stock at an exercise price of \$37.40 per share, but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004, and March 13, 2007.
- (2) Accordingly, on March 13, 2007, the date the stock dividend was paid, the option became exercisable for 162,737 shares an an exercise price of \$16.62 per share.
