- (1) Restricted shares granted under the Zions Bancorporation 2005 Stock Option and Incentive Plan. Restricted shares vest 25% per year for 4 years. Any vesting or lapse of restrictions is subject to TARP regulations.

These shares are issuable in respect of restricted stock units that represent a portion of the reporting person's salary, net of withholdings and deduction, and that were issued under the Zions Bancorporation 2005 Stock Option and Incentive Plan. Restricted stock units are 100% vested on the date of grant but are subject to transfer restrictions that lapse beginning on September 30, 2012 and that lapse in full on the reporting person's earlier death.
