This Prospectus Supplement supplements the Prospectus dated October 5, 2000 (the "Prospectus Supplement") of Cisco Systems, Inc. (the "Company") relating to the public offering, which is not being underwritten, and sale by certain shareholders of the Company or by pledgees, donees, transferees or other successors in interest that receive such shares as a gift, partnership distribution or other non-sale related transfer (the "Selling Shareholders") of 18,340 shares of Common Stock, par value of \$0.001 per share, of the Company (the "Common Stock") who received such shares in connection with the acquisition by statutory merger of IPMobile, Inc. ("IPMobile1"), by and through a merger of IPMobile with and into the Company. This Prospectus Supplement should be read in conjunction with the Prospectus, and this Prospectus Supplement is qualified by reference to the Prospectus except to the extent that the information herein contained supersedes the information contained in the Prospectus. Capitalized terms used in this Prospectus Summary and not otherwise defined herein have the meanings specified in the Prospectus.
