- These shares represent: (a) 8,000 restricted stock units that will be settled in LEADS common stock upon vesting, 25% of the restricted stock units will vest on January 20 in each of 2012, 2013, 2014 and 2015, subject to the Reporting Person's continuous employment through each of the vesting dates, and will become fully vested upon a change in control; and (b) 50,000 restricted stock units that will be
- (1) settled in LEADS common stock upon vesting, 25% of the restricted stock units will vest on February 20 in each of 2013, 2014, 2015 and 2016, subject to the Reporting Person's continuous employment through each of the vesting dates. Vested shares will be delivered to the reporting person within the first open trading window following the vesting date, but in no event later than the 15th day of the 3rd month following the end of the Company's tax year that includes the vesting date.
  - (2) The option shares vest and become exercisable in four equal successive annual installments over the next 48 months of continuous service after May 30, 2010.
  - (3) 25% of the option vests and becomes exercisable upon the completion of each of 4 years of service following January 20, 2011 and will become fully vested and exercisable upon a change in control.
