In connection with Mr. Hulse's departure and in accordance with his employment agreement with the Company, dated April 22, 2013, Mr. Hulse is entitled to receive 12 months of base salary payable over 12 months, a pro rata payment of his annual target bonus, 12 months of continued health benefits and 12 months of vesting credit under his outstanding equity awards.
