- (1) Shares of common stock acquired upon the vesting of performance stock units awarded on February 20, 2009.  - (6) The Time Warner Savings Plan, a qualified employee benefit plan (the "Savings Plan"). Includes shares of common stock acquired through the reinvestment of dividends paid on the common stock held by the Savings Plan.
 - (7) These restricted stock units vest in two equal installments on the third and fourth anniversaries of their dates of grant, February 20, 2009, February 8, 2010, and February 7, 2011.
