  - (1) Reflects an award value of \$1,325,000 converted to a number of Restricted Stock Units by dividing the approved award value by \$343.855, which was the average of the high and low price per share of Common Stock on January 16, 2015. This grant was approved by the Management Development and Compensation Committee on January 13, 2015. Restricted Stock Units vest in installments with 33% vesting on 1/31/16, 33% vesting on 1/31/17 and 34% vesting on 1/31/18.
  - (2) Includes 222.96 shares of Common Stock acquired by the reporting person under the BlackRock, Inc. Employee Stock Purchase Plan.
