- (1) The restricted stock units vest 3 years from the grant date on February 11, 2017.
- (2) The restricted stock units include all dividend equivalents acquired since the date of grant. Dividend equivalents are subject to the same restrictions as the underlying grant of restricted stock units.
- (3) The restricted stock units vest 3 years from the grant date on February 4, 2018.
- (4) The restricted stock units vest 3 years from the grant date on February 10, 2019.
- (5) SARs become exercisable and vest only upon the achievement of both price and time requirements. To vest, each one-third of the grant must attain 10%, 15% and 20% stock appreciation, respectively (which must be maintained for a minimum of thirty consecutive trading days) from the February 15, 2013 closing price of \$23.08 per share and no more than one-third of the grant can vest per year during the first three years.

(7) SARs become exercisable and vest only upon the achievement of both price and time requirements. To vest, each one-third of the grant must attain 10%, 15% and 20% stock appreciation, respectively (which must be maintained for a minimum of thirty consecutive trading days) from the grant date closing price of \$38.27 per share and no more than one-third of the grant can vest per year during the first three years.

(8) SARs become exercisable and vest only upon the achievement of both price and time requirements.
