As of the date of this filing, Millenco LLC, a Delaware limited liability company ("Millenco"), is deemed to be the beneficial owner of 4,376,105 shares of the Company's Common Stock as a result of holding the following:

(i) 4,331,777 warrants ("Warrants") to purchase the Company's Common Stock. Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$7.50 per share. Each Warrant will expire on June 18, 2011, or earlier upon redemption; and

(ii) 44,328 shares of the Company's Common Stock.

Note: Millenco maintains an open short position of 401,918 shares of the Company's Common Stock, which position is not netted against the data provided herein as to the number of shares beneficially owned by Millenco LLC.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the manager of Millenco, and consequently may be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the shares owned by Millenco.
