(5) Pursuant to Rule 16a-1(a)(4) of the Act, Mr. Kewsong Lee herein states that this filing shall not be deemed an admission that he is the beneficial owner of any of the shares of Common Stock held by WP X or of any of the warrants exercisable for Common Stock held by WP X.
