 - (4) Total includes 1167.658 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 22,090 Restricted Stock Units, of which 16,206 are subject to future vesting, 10,944 Market Share Units, all of which are subject to future vesting, and 5,780 PSUs, all of which are vested.
