(1) Options become exercisable in 25% increments on the first, second, third and fourth anniversary dates of the grant.

Upon vesting, payout under the RSUs will be in the form of shares or, at the discretion of the Compensation Committee of the Board of Directors, the cash value thereof. No dividend, voting or other shareholder rights attach to the RSUs until they vest and only if the payout upon vesting is in shares of common stock.

(3) Subject to performance vesting condition based on diluted earnings per share growth.

(4) Each share of phantom stock represents the right to receive the cash value of one share of McDonald's Corporation common stock.

(5) Shares of phantom stock are payable in cash following the reporting person's separation from service with McDonald's.
