- (4) The amount of securities shown as beneficially owned by Mr. Heffron on Table I has been reduced by 36,004 RSUs, which were previously reported on Table I. This Form 4 reflects the previously reported 12/1/14 grant of 21,004 RSUs, and 12/1/13 grant of 15,000 RSUs on Table II.

- (8) The date of grant of the RSUs was December 1, 2013. Each RSU represents the right to receive one share of common stock of the Company or its cash equivalent upon the vesting date, subject to the terms and conditions described in footnote 6 above.
