- (1) The two reported transactions involved an amendment of an outstanding option, resulting in the deemed cancellation of the "old" option and the grant of a replacement option. The "old" option, which was originally granted on January 26, 2010, provided for vesting over 48 months at a rate of 1/48th of the grant per month such that 100% of the options would be fully vested and exercisable on January 26, 2014, and pursuant to which vested options would have expired three months following Dr. Bauer's resignation as a Director. As amended, 50,000 options are fully vested as of Dr. Bauer's resignation on June 24, 2010, and the expiration date has been extended to June 30, 2012.
