Potential earning dates for such shares will occur in three annual installments commencing March 8, 2015 through March 8, 2017.
  - (4) Includes 13,952 Performance Share Rights awarded in 2013 with potential earning dates in three annual installments commencing March 8, 2014 through March 8, 2016.
