On May 3, 2012, Southside Bancshares, Inc. issued a press release announcing financial results for the three months ended March 31, 2012, reporting earnings of \$10.1 million and diluted earnings per common share of \$0.58. The press release includes information regarding interest income on a taxable equivalent basis or FTE. FTE is a non-GAAP performance measure used by management in operating the business which management believes provides investors with a more accurate picture of the interest yield, spread and margin for comparative purposes.
