The shares will be issued to the reporting person on February 28, 2017.

(3) Employee stock option granted pursuant to the AbbVie 2013 Incentive Stock Program in a transaction exempt from Section 16 under Rule 16b-3. The option becomes exercisable in annual increments of 15,234 on 02/16/2018, 15,233 on 02/16/2019, and 15,233 on 02/16/2020.
