- (2) The total direct beneficial ownership reflects a decrease of 49,805 shares due to the transfer of 49,805 shares into a Joint Living Trust with the reporting person's spouse on 12/01/10.
- (3) The total indirect beneficial ownership reflects an increase of 49,805 shares due to the transfer of 49,805 shares previously reported as being held directly by the reporting person into a Joint Living Trust with the reporting person's spouse on 12/01/10.
- These shares were held indirectly under HP's 401(k) Plan as of 11/30/10. Fidelity Investments Institutional Services Company, Inc.
- (4) accounts for holdings in the stock fund in units, which are comprised of stock and cash reserves. The shares reported represent an approximate value based upon the fund balance and market value of HP's common stock.
