- (1) On October 18, 2005, Orange Merger Corp., a wholly-owned subsidiary of Océ N.V., acquired 13,018,344 shares of Imagistics International Inc. common stock, par value \$0.01 per share, including the associated Series A Junior Participating Preferred Stock purchase rights (together, the "Shares"), at the expiration of, and pursuant to, the offer to purchase all of the outstanding Shares dated as of September 19, 2005 and had notices of guaranteed delivery with respect to an additional 561,711 Shares. During the subsequent offering period for all remaining untendered Shares, which expired on October 25, 2005, Orange Merger Corp. acquired an additional 239,117 Shares. The subsequent offering period was extended until October 28, 2005, on which date the additional shares noted herein were acquired.
