- (1) Disposed of pursuant to the merger of Vision Bancshares, Inc. ("Vision") with and into Park National Corporation ("Park") on March 9, 2007. Under the terms of the merger agreement, Vision shareholders had the option of receiving \$25 cash or 0.2475 Park common shares (or a combination thereof) for each of their Vision shares, subject to the allocation and election procedures in the merger agreement. On March 15, 2007, Park announced that 50% of the total Vision shares outstanding at the time of the merger would be exchanged for Park common shares (which had a closing price of \$92.25 on the merger date), and 50% for cash, with shareholder election requests to receive cash prorated by a factor of 0.287407803.
