- (1) Pursuant to the issuer's Board of Directors Compensation Plan, the board of directors granted \$100,000 of common stock to each non-employee director under the issuer's 2007 Equity Incentive Plan, based on the \$3.57 closing price of the common stock on June 25, 2009, as quoted on the NASDAQ Global Select Market.
- (2) Pursuant to the issuer's Board of Directors Compensation Plan, the reporting person elected to receive \$85,000 of restricted stock issued under the issuer's 2007 Equity Incentive Plan as his director compensation. The restricted stock issued to the reporting person is based on the \$3.57 closing price of the issuer's common stock on June 25, 2009, as quoted on the NASDAQ Global Select Market. The restricted stock vests in four equal installments on September 25, 2009, December 25, 2009, March 25, 2010 and June 25, 2010.
