- (1) On 02/23/2010, the reporting person was granted an option to purchase 1,915,499 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 02/23/2010) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.
- (2) As a result of the sale of shares by the Sponsors, the performance criteria was met with respect to 39,076 shares of common stock subject to this option award, resulting in vesting of the option as to 15,630 shares and an additional 23,445 shares that are eligible to vest in three equal annual installments beginning on 02/23/2012. In total, following this event, the performance criteria has been met with respect to an aggregate of 546,683 shares of common stock subject to this option award, with 218,699 of such shares vested and the remaining 327,984 of such shares eligible to vest in three equal annual installments beginning on 02/23/2012.
