- (1) This amended Form 4 is being filed to reflect that the transactions in the original filing (filed on July 26, 2012) were exempt pursuant to Rule 16b-3(d) of the Exchange Act of 1934.

- (2) On July 24, 2012, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 37,500 of the 150,000 Performance Shares granted to Mr. Luczo on January 30, 2009. The 37,500 shares will vest on January 30, 2013 (or, in certain circumstances, at the opening of the next following trading window), subject to continuous service through such date.

- (3) On July 24, 2012, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 65,000 of the 260,000 Performance Share Units granted to Mr. Luczo on September 12, 2011. The 65,000 shares will vest on September 12, 2012 (or, in certain circumstances, at the opening of the next following trading window), subject to continuous service through such date.
