(1) The number of deferred stock units was adjusted in connection with the separation (the "Separation") of News Corporation from Twenty-First Century Fox, Inc. on June 28, 2013. The adjustment was based on the ratio of the pre-Separation closing price on June 28, 2013 of Twenty-First Century Fox, Inc.'s Class A common stock and the volume weighted average price of Twenty-First Century Fox, Inc.'s Class A common stock on July 1, 2013.

(2) The deferred stock units were deemed to have settled for cash value of an equivalent number of shares of Twenty-First Century Fox, Inc.'s Class A Common Stock.

(3) Each deferred stock unit represents the equivalent of one share of Twenty-First Century Fox, Inc.'s Class A Common Stock.
