Item 1.01 Entry Into a Material Definitive Agreement

Nord Resources Corporation (the "Corporation") has entered into an extension agreement with respect to its replacement cathode sales agreement with Red Kite Master Fund Limited ("Red Kite") that covered the period from January 1, 2013 through December 31, 2013, for 100% of the copper cathode production from the Johnson Camp Mine. The extension runs through March 31, 2014 with renewable extensions by mutual agreement of both parties. Pursuant to the agreement, Red Kite will accept delivery of the cathodes at the Johnson Camp Mine, and pricing will be based on the COMEX price for high-grade copper on the date of sale. Red Kite is a large metals hedge fund and physical trader.

The Corporation is planning to file the extension agreement as an exhibit to its annual report on Form 10-K for the year ended December 31, 2013.
