The shares of phantom stock relate to shares of restricted stock granted under the Cleco Corporation Long-Term Incentive Compensation Plan. No separate value was exchanged for these shares. The restrictions on these shares lapse on January 26, 2013 or earlier mandatory retirement. The reporting person will receive a proportionate amount of such shares if she retires, dies or is disabled prior to January 26,

- (1) 2013. The reporting person has elected to defer receipt of these shares under the Cleco Corporation Deferred Compensation Plan (the "Plan"). Each share of phantom stock is the economic equivalent of one share of Cleco Corporation common stock. Shares of phantom stock may be transferred by the reporting person into an alternative investment account at any time pursuant to the terms and provisions of the Plan.

Includes 585 shares of phantom stock (not subject to restrictions) related to dividend reinvestment on shares of phantom stock pursuant to the terms and provisions of the Cleco Corporation Deferred Compensation Plan. Includes (a) 1,200 shares of phantom stock subject to

- (2) restrictions that lapse on July 23, 2010; (b) 2,339 shares of phantom stock subject to restrictions that lapse on January 28, 2011; (c) 2,228 shares of phantom stock subject to restrictions that lapse on January 27, 2012; and (d) 1,846 shares of phantom stock subject to restrictions that lapse on January 26, 2013.
