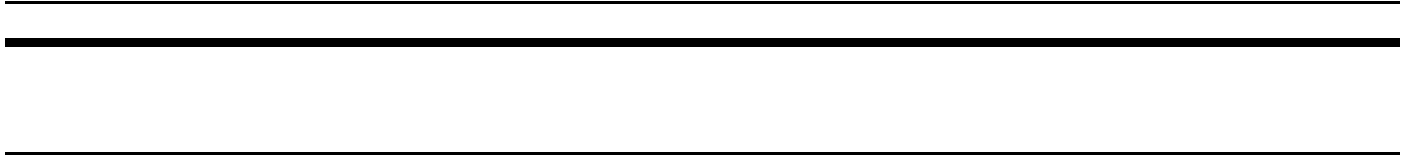

The 2013 Annual Meeting of Shareholders of RPC, Inc. (the “Company”) was held on April 23, 2013.
