***Gold Fields management continues to waste its shareholders money on expensive and frivolous legal actions***

Further to Gold Fields numerous public statements that it intended to appeal to the Executive Committee of the SRP on the grounds that Harmony's offer for Gold Fields had already lapsed, the Executive Committee met today to consider the appeal. At the hearing, Gold Fields withdrew its appeal without having made any arguments on the merits of its appeal and the Executive Committee accordingly dismissed the appeal with costs.

Harmony believes that this is yet another example of Gold Fields management wasting what amounts to millions of US dollars of its shareholders money on ill-conceived, expensive and frivolous legal actions. It is the latest instalment of the long campaign by Gold Fields management designed to frustrate Gold Fields shareholders ability to consider Harmony's offer.

Harmony CE, Bernard Swanepoel said: It is time for Gold Fields management to stop wasting these huge amounts of their shareholders money purely to keep the Gold Fields management team in their jobs. The only people benefiting from this are Gold Fields lawyers. The consistent losers are Gold Fields shareholders.

I understand that Gold Fields management's latest plan is to take the regulators to court. This is clearly ridiculous and shows a fundamental disrespect for the rules and institutions of the Republic of South Africa. It is time for this expensive comedy to end.
