On June 7, 2007, Biomet, Inc. ( Biomet ) announced that it cancelled the special meeting of shareholders previously scheduled for Friday, June 8, 2007 to consider and vote on the Agreement and Plan of Merger dated December 18, 2006, by and between Biomet and a consortium of private equity funds. The special meeting has been cancelled as a result of the adoption by Biomet's board of directors on June 6, 2007 of an amended and restated Agreement and Plan of Merger between the same parties.
