Attached is an English translation of the summary of the letter dated November 19, 2007 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated November 8, 2007, the Company reported that on November 14, 2007, several holders of the Company's Convertible Notes exercised their warrant rights. Hence, a reduction of 1,388,893 warrants and an increase of 2,735,104 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 318,039,668 to 320,774,772. Having the term for exercising the warrant rights expired on November 14, 2007, the final amount of warrants outstanding is 132,982. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6093 for each share face value pesos 1. Therefore US\$ 1,666,498 entered into the Company.
