**Item 7.01. Regulation FD Disclosure**

***Notes Offering***

On January 12, 2010, Verso Paper Corp. ( Verso ) announced the intent of its subsidiaries, Verso Paper Holdings LLC ( Verso Holdings and, together with Verso, the Registrants ) and Verso Paper Inc., a subsidiary of Verso Holdings (together with Verso Holdings, the Issuers ) to offer, subject to market and other conditions, \$25 million aggregate principal amount of senior secured notes due 2014 (the Notes ) through a private placement that is exempt from the registration requirements of the Securities Act of 1933, as amended (the Securities Act ). The Notes will have the same terms as the \$325 million aggregate principal amount of senior secured notes due 2014 issued by the Issuers on June 11, 2009.

The Notes are being offered only to qualified institutional buyers in reliance on Rule 144A under the Securities Act, and outside the United States only to non-U.S. investors pursuant to Regulation S. The Notes will not initially be registered under the Securities Act or any state securities laws and may not be offered or sold in the United States absent an effective registration statement or an applicable exemption from registration requirements or a transaction not subject to the registration requirements of the Securities Act or any state securities laws.

This report shall not constitute an offer to sell or the solicitation of an offer to buy any security and shall not constitute an offer, solicitation or sale in any jurisdiction in which such offering, solicitation or sale would be unlawful.

***Alternative Fuel Mixture Tax Credits***

Until December 31, 2009, the United States government provided an excise tax credit to taxpayers for the use of alternative fuel mixtures. As a result of Verso's use of an alternative fuel mixture containing black liquor, a byproduct of pulp production, at its Androscoggin and Quinnesec mills, Verso expects to recognize between \$234 million and \$244 million of alternative fuel mixture tax credits in the year ended December 31, 2009, including approximately \$10 million for claims pending at December 31, 2009. The amount recognized in fiscal 2009 includes amounts received for claims for use of the alternative fuel mixture from September 2008 through December 2009. The tax credit, as it relates to liquid fuels derived from biomass, expired on December 31, 2009. Therefore, Verso will not recognize any proceeds from this tax credit in future periods. In addition, one of Verso's customers, Thilmany, LLC, has served it with a lawsuit claiming a right to an unspecified portion of the alternative fuel mixture tax credits related to the operation of its Androscoggin mill.

The Registrants are furnishing this information under Item 7.01 of this report to comply with Regulation FD. Such information shall not be deemed to be filed for purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the Exchange Act ), or otherwise subject to the liabilities of that section, and shall not be deemed to be incorporated by reference into any of the Registrants' filings under the Securities Act or the Exchange Act, whether made before or after the date hereof and regardless of any general incorporation language in such filings, except to the extent expressly set forth by specific reference in such a filing.
