As previously announced, in connection with its proposed acquisition of Convio, Inc., a Delaware corporation, Blackbaud, Inc. voluntarily withdrew its Premerger Notification and Report Form (the Form) from the Federal Trade Commission (the FTC) and the Department of Justice (the DOJ) effective February 3, 2012. Blackbaud took this procedural step in order to facilitate FTC and DOJ review of the proposed acquisition. Blackbaud refiled the Form with the FTC and DOJ on February 7, 2012. Upon refiled, the waiting period under the Hart-Scott-Rodino Antitrust Improvements Act of 1976 will expire at 11:59 p.m., New York City time, on February 22, 2012, unless earlier terminated by the FTC and the DOJ or Blackbaud receives a request for additional information or documentary material prior to that time.

Forward-Looking Statements

This Current Report on Form 8-K contains forward-looking statements relating to the acquisition of Convio by Blackbaud and the companies potential combined business.
