**In response to media inquiries, Halliburton Company issued the following statement to certain media outlets:**

**Response to Brazilian Administrative Council for Economic Defense (CADE) Regulatory Opinion**

We are aware of the opinion issued by the Brazilian General Superintendence of the Administrative Council for Economic Defense (CADE) regarding Halliburton's pending acquisition of Baker Hughes, which provides its non-binding view regarding the transaction to the Tribunal, CADE's decision-making authority. This is a normal step in CADE's review process.

Halliburton and Baker Hughes continue to work constructively with all competition enforcement authorities that have expressed interest in the proposed transaction, including the authorities in Brazil. To date, the transaction has received unconditional regulatory clearances in Canada, Colombia, Kazakhstan, South Africa and Turkey.

Halliburton and Baker Hughes remain focused on completing the regulatory approval process and closing the transaction in order to begin realizing the benefits of the combination for shareholders, customers and all other stakeholders.
