EXPLANATORY NOTE: This Amendment No. 19 to Schedule 13D (Amendment No. 19) relates to the Class A Common Stock, \$0.01 par value per share, of Hyatt Hotels Corporation, a Delaware corporation (the Issuer), which has its principal executive office at 71 South Wacker Drive, 12th Floor, Chicago, Illinois 60606.
