This Amendment No. 3 to the Schedule 13G (this Schedule 13G) relates to shares of Common Stock, par value \$.01 per share (Common Stock), of Interactive Brokers Group, Inc., a Delaware corporation (the Issuer), and is being filed on behalf of (i) Teton Capital Partners, L.P. (the Fund), a Texas limited partnership, (ii) Ancient Art, L.P. (Ancient Art), a Texas limited partnership, as the investment manager to the Fund, (iii) Whitney, L.P. (Whitney), a Texas limited partnership, as the general partner of the Fund, (iv) Trango II, L.L.C. (Trango), a Texas limited liability company, as the general partner of both Ancient Art and Whitney, and (v) Quincy J. Lee, the principal of Trango (collectively, the Reporting Persons). The shares of Common Stock reported on this Schedule 13G are held by the Fund and Mr. Lee individually.

Ancient Art, Whitney and Trango may be deemed the beneficial owners of 3,301,252 shares of Common Stock held by the Fund. Mr. Lee may be deemed the beneficial owner of 3,489,717 shares of Common Stock held by the Fund and Mr. Lee directly.
- (b) The Fund, Ancient Art, Whitney and Trango may be deemed the beneficial owners of 4.9%, and Mr. Lee may be deemed the beneficial owner of 5.1%, of the Issuer's outstanding shares of Common Stock. These percentages were calculated by dividing the number of shares of Common Stock beneficially owned by each of the Reporting Persons, by 67,982,963, the number shares of Common Stock issued and outstanding as of November 9, 2016, as reported in the Issuer's most recent Form 10-Q filed with the Securities and Exchange Commission on November 9, 2016.
- (c) The Fund has the sole power to vote and dispose of the 3,301,252 shares of Common Stock it holds directly. Ancient Art, Whitney, Trango and Mr. Lee have the shared power to vote and dispose of the 3,301,252 shares of Common Stock held by Fund. Mr. Lee has the sole power to vote and dispose of the 188,465 shares of Common Stock he holds directly
