On October 12, 2018, Equinix, Inc. ( Equinix ) and Charles Meyers, Equinix s Chief Executive Officer and President, agreed to amended terms governing his relocation to Redwood City, CA. As relocation assistance, Mr. Meyers will receive a one-time cash payment of \$300,000, subject to Federal, State and Medicare withholding taxes. In addition, Equinix shall offer support to Mr. Meyers in selling an existing residence through a structured home sale program. Should Mr. Meyers s employment with Equinix terminate within 12 months from October 12, 2018, voluntarily or for cause, all relocation assistance must be repaid in full to Equinix.
