Security and Issuer

This Schedule 13D is being filed jointly on behalf of Christopher Bunka, C.A.B. Financial Services Ltd., and 0743608 B.C. Ltd, (together the "Reporting Persons") relating to the shares of common stock, par value \$0.001 ("Common Stock") of Golden Aria Corp., a corporation formed under the laws of the State of Nevada (the "Issuer"). The Reporting Persons may act independently in evaluating and effecting any such transactions.
