- (1) Award of a restricted stock grant which vests after five years.
- (2) Includes 96.623 shares acquired through the reinvestment of dividends on March 31 and June 30, 2006, at prices of \$ 76.0258 and \$81.9283 per share.
- (3) The number of underlying securities is based on the stock fund balance on August 1, 2006. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on an August 1, 2006 stock fund price of \$75.81 per share.
- (4) The phantom stock units convert to the common stock's cash value on a one-for-one basis.
- (5) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's retirement.

- (7) The phantom stock units were accrued under the Johnson Controls Annual Incentive Plan and are to be settled 100% in cash upon retirement.
- (8) Includes 0.164 fractional phantom stock unit acquired through the reinvestment of dividends on March 31 and June 30, 2006, at prices of \$75.93-\$82.225 per phantom unit.
- (9) The phantom stock units were accrued under the Johnson Controls Long-Term Incentive Plan and are to be settled 100% in cash upon retirement.
- (10) Includes 0.303 fractional phantom stock unit acquired through the reinvestment of dividends on March 31 and June 30, 2006, at prices of \$75.93-\$82.225 per phantom unit.
- (11) The phantom stock units were accrued under the Johnson Controls Deferred Restricted Stock Plan and are to be settled 100% in cash upon the reporting person's retirement.
- (12) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
