 - (3) The option became fully exercisable as of February 19, 2001, the third anniversary of the grant date.
 - (4) Option held by a Grantor Retained Annuity Trust of which Mr. Ayer is Trustee.
 - (5) The option became fully exercisable as of April 15, 1999, following the achievement of the following criteria: the closing price of the Issuer's Common Stock on the New York Stock Exchange reached 125% of the grant price for at least 10 consecutive trading days.
 - (6) The option became fully exercisable as of August 16, 2000, following the achievement of the following criteria: the closing price of the Issuer's Common Stock on the New York Stock Exchange reached 125% of the grant price for at least 10 consecutive trading days.
