- (1) The phantom stock units will convert into shares of Sara Lee common stock on a one-for-one basis.  
Represents director fees deferred and dividend reinvestment credits accrued in the reporting person's account in the Sara Lee Corporation Non-Employee Director Compensation Program. Of this amount, 331,824 shares units were acquired on September 29, 2006 at a price of \$16.01 per share. The remaining share units were acquired at various times as dividend reinvestment credits and as an adjustment resulting from the spin off (as described in footnote 4 below).
- (2) The reporting person will receive shares of Sara Lee common stock, on a one-for-one basis, at a future date(s) specified by her pursuant to the deferred compensation plan.  
On September 5, 2006, Sara Lee Corporation ("Sara Lee") distributed, as a pro rata stock dividend, all of the shares of its wholly-owned subsidiary, Hanesbrands Inc. ("Hanesbrands"), to holders of record of Sara Lee common stock as of the close of business on August 18, 2006 (the "spin off"). Effective upon completion of the spin off, the Compensation and Employee Benefits Committee of Sara Lee's Board of Directors adjusted all outstanding Sara Lee equity awards (including phantom stock units) to preserve their pre-spin off intrinsic value. As a result, on September 6, 2006 the reporting person received additional share units, which are reflected in this total.
