- RSUs awarded pursuant to the fulfillment of Performance share units awarded last year. - (1) The SAR's were issued at the average of the high and low price of the Company's stock on February 21, 2007 (\$47.705). They will vest in equal amounts over three years commencing on the first anniversary of the grant and will expire ten years after the grant date. Additional terms apply in the event of the holder's termination, death or retirement.
