- (1) Corillian Corporation was acquired by CheckFree Corporation on May 15, 2007, resulting in a change of control, pursuant to which each share of Corillian Common Stock was exchanged for the right to receive \$5.15 in cash.

- At the effective time of the acquisition of Corillian Corporation by CheckFree Corporation, the vesting of all outstanding stock options
- (2) accelerated, each outstanding stock option was converted into the right to receive the excess, if any, of \$5.15 over the exercise price per share of such stock option, and each outstanding stock option was then terminated upon the change of control.
