- (1) These restricted stock units were granted under the Endo Pharmaceuticals 2007 Stock Incentive Plan and vest ratably over a two-year period, 50% on March 12, 2010 and 50% on March 12, 2011, and will be settled in common stock.
- (2) These securities were granted to Mr. Scodari in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors.
