- (1) This amendment is being filed to correct an administrative error in the issuer's internal reporting of the number of units awarded. Represents Restricted Stock Units ("RSUs") awarded under the Winn-Dixie Stores, Inc. Fiscal 2010 Equity Incentive Plan. The RSUs
- (2) become vested, and certificates for shares of common stock become deliverable, in three equal annual installments beginning on the first anniversary of the date of grant. Each RSU represents a contingent right to receive one share of Winn-Dixie Stores, Inc. common stock.
- (3) The amount of securities owned balance includes 46,566 RSUs for which stock certificates will be issued upon vesting.
- (4) The Option shall vest in equal annual installments over 3 years beginning with the first anniversary of the date of grant.
