- (1) This transaction represents a distribution of shares from the issuer's Employee Stock Ownership Plan ("ESOP") to terminated plan participants. Mr. Wilkins serves as one of two co-trustees for the plan.
- (2) The price per share is the closing price of the issuer's common stock on the date of the reported transaction.  
The number of securities beneficially held following the reported transaction includes: 2,748 shares held individually by Mr. Wilkins; 2,313 shares of restricted stock issued under the issuer's 2008 Stock Plan, which vest, subject to certain conditions, on 05/21/2013;
- (3) 202,058 shares held in the issuer's defined benefit pension plan, for which Mr. Wilkins serves as one of two co-trustees; and 234,107 shares held in the issuer's ESOP, for which Mr. Wilkins serves as one of two co-trustees.  
None of the shares held by the issuer's defined benefit pension plan are allocated for Mr. Wilkins' individual benefit. Only 1,575 shares held in the issuer's ESOP are allocated for Mr. Wilkins' individual benefit. Mr. Wilkins' disclaims beneficial ownership of any shares held
- (4) by these two plans that are not allocated for his individual benefit, and this report shall not be deemed an admission that Mr. Wilkins is the beneficial owner of such securities for purposes of Section 16 or for any other purpose.
