(1) Consists of restricted stock units (RSUs) granted for serving as Chairman of the Board during the second half of calendar 2010, including RSUs that the reporting person elected to receive in lieu of the cash portion of his retainer. The RSUs will vest on January 4, 2011 and will be converted into shares of Sara Lee common stock on a one-for-one basis on the date six months after the reporting person ceases to be a director of Sara Lee.

RSUs vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis. The settlement date is six months after the reporting person ceases to be a director of Sara Lee.
