(1) This number includes: 1) 15,625 restricted stock units ("RSUs") granted to the reporting person as a portion of his compensation. RSUs are calculated on a one unit for one share basis. A portion of these RSUs vest on February 4, 2012 and a portion vests on February 4, 2013. Vesting of all RSUs is contingent upon the reporting person's continued employment with the company; 2) 8,627 performance-based restricted stock units ("PSUs") granted to the reporting person as a portion of his compensation from PepsiCo, Inc. These PSUs will become vested on March 1, 2014 contingent upon the achievement of pre-established performance targets over a two-year performance period and Compensation Committee approval. The reporting person may receive a number of shares of PepsiCo Common Stock from 0% to 125% of the PSUs granted, depending on the performance level achieved; and 3) 441 units of PepsiCo, Inc. Common Stock held in a personal brokerage account.
